

Current NPSBN Deployables Fleet

- 72 FirstNet-dedicated deployable assets available nationwide
- Subscribing agencies can request deployables to support disasters, critical incidents, and planned events
- Service includes all expenses directly associated with FirstNet deployables at no additional cost to FirstNet subscribers





Coverage Enhancement Opportunity Overview

Public Safety Feedback

- Public safety wants transparency on where coverage exists today and the ability to guide where it will expand in the future
- Fixed, reliable wireless broadband coverage is preferred for public safety operations especially as it becomes foundational to public safety communications
- Temporary coverage solutions must be readily available to an agency and their use must easily integrate into public safety operations

Roadmap Priorities

- Increase outdoor and indoor coverage, particularly Band 14, at locations deemed to be public safety priorities
- Advocate for changes in policies, codes, and standards to facilitate inbuilding coverage enhancements
- Grow and enhance the deployable fleet considering varying operational needs, staging locations, and technology options

Expand Deployable Capability


To increase and optimize the FirstNet deployables service

Increases public safety sentiment and differentiates the FirstNet Solution through dedicated and readily available deployable capability



72 FirstNet-Dedicated Deployables Nationwide

- Demonstrated success
 providing temporary coverage and capacity solutions that easily integrate into public safety operations
- Increased demand since the availability of the service
- Anticipated growth in public safety adoption of FirstNet will result in more requests for deployable services








Hurricane Response Example

- Restored coverage in outage areas








Network Enhancement Investment Recommendation



Enhance the FirstNet Core for 5G network capabilities

Current FirstNet Network

- Public safety always gets priority and preemption
- Highly secure network to meet public safety's data requirements
- Controlled access by public safety agencies for their users
- Coverage where public safety operates
- Enhanced user experience





Network Enhancement Investment Opportunity Overview

Public Safety Feedback

- A dedicated core is necessary to ensure mission-critical levels of availability, reliability, priority, and security
- The public safety community expects the FirstNet core to remain current with the continued evolution of features, functions, and capabilities as specified in standards and available by technology providers

Roadmap Priorities

- Advance mobile broadband priority standards for public safety through continued involvement in relevant standards development and exploration
- Begin work on greater core distribution/cloud-based operations in more locations with content closer to users
- Investigate the evolution for the Core to take advantage of emerging technologies and ensure foundations are in place for next generation enhancements (e.g., 5G)


Initiate Core Generational Upgrade

FIRST RESPONDER NETWORK AUTHORITY BOARD RESOLUTION 102

COVERAGE ENHANCEMENT AND NETWORK ENHANCEMENT INVESTMENT RECOMMENDATIONS

WHEREAS, during the September 18, 2019, Combined Committee and Board meeting, the Board has been presented with and discussed a Coverage Enhancement Investment Recommendation to expand the NPSBN deployables fleet, consistent with priorities identified within the FirstNet Authority's Coverage & Capacity Roadmap Domain.

WHEREAS, during the September 18, 2019, Combined Committee and Board meeting, the Board has been presented with and discussed a Network Enhancement Investment Recommendation to initiate generational upgrades to the FirstNet Core, consistent with priorities identified within the FirstNet Authority's Core Roadmap Domain.

NOW THEREFORE BE IT RESOLVED that the Board authorizes the FirstNet Authority management to move forward with the Coverage Enhancement and Network Enhancement Investment Recommendations and directs the FirstNet Authority management to take all actions necessary to implement the proposals in accordance with the objectives and business cases as presented to the Board.

NOW THEREFORE BE IT FURTHER RESOLVED that the Board approves the above-referenced Investment Recommendations and associated implementation actions by the FirstNet Authority management, in accordance with the objectives and business cases as presented to the Board.
